Dear Colleagues:

We finished the December newsletter after a very active year in all IPSO regions. You will get to know what happened in the last months in every region and what will come, thanks to the reports written by my colleagues from the Executive Committee.

The heading of this report has to do with the topic of the last FEPAL (Latin-American Psychoanalytic Federation) Congress, held in São Paulo, Brazil, INVENTION - TRADITION. Our responsibility as psychoanalysts-in-training is to distinguish what is being passed on that helps us think in a creative, enlivened way from what is being passed on that is repetitive adoration of an idealized past. We ourselves, are responsible for keeping the flame alive, for transforming ourselves as agents of change, making the tradition an awakening fire that makes our inner world alive, and keeping away from contemplation of the bonfire's ashes. In this way, I believe that institutional participation offers the foundation and support to grow individually and within a group.

I'd like to take this occasion to send my congratulations and my wishes for successful work to two colleagues leading other candidates' organizations. Cecilia Moia, from Argentina, is the new president of OCAL (Latin-American Candidates' Organization) and Navah Kaplan, from the United States, is President of the APSaA Candidates' Council.

As IPSO, we would like to encourage candidates to participate in the IPA through IPSO organized activities. IPSO has been trying to gain more support for candidates from the IPA. I have been working together with the IPA, through the IPA/IPSO Standing Committee, which is not only in charge of the administration of the Tyson Prize but is also a channel which can be used by both candidates and IPA members to share ideas and concerns. We are organizing a project to study training and the current situation of candidates, to present to the IPA. I hope to count on your collaboration because I think it is our opportunity to be heard and achieve some changes.

IPSO continues to collaborate with the IPA Ageing Committee, and its research about age of the candidates and related issues. This project started with the help of our former IPSO President, Luisa Marino. One part of the research was presented last year in Mexico, during the IPA/IPSO Congress. Next year, during the European Federation Congress, which will be held in Basel, Switzerland, it will be presented under the topic: "Formlessness, Deformation, Transformation," and new results will be presented. This time they will have to do with how the psychoanalytic culture is transmitted through different generations of

analysts. Questions such as what sort of culture is transmitted to the younger generation by institutes of analysts whose average age is 60, and what is the impact in the creation of an analytic identity, deformation or transformation experience, will be considered. IPSO provides the Committee, with our member's birthdates which are used for statistical purposes and outreach measures.

Last, I'd like to tell you that the IPSO Congress in Prague is coming with all its strength! We will have new activities such as the "Listening to the Listening" method workshop with Dr. Haydée Faimberg. Dr. Faimberg gave this workshop for candidates during the European Federation Congresses. Also in Buenos Aires, in the Argentinean Psychoanalytical Association, last August, we had the chance to have this activity with Dr. Faimberg. This is a valuable opportunity to listen to the material presented by a colleague in a respectful way, to learn how to discuss and think what we say from what we have said and listening from what we have listened. In our attempt of creating a more attractive Congress, we will count with this activity and we are still waiting for others to be confirmed. We will tell you more later.

During the Congress, IPSO will be electing new officers to be part of the next Executive Committee. The following positions will be available: President-Elect; Vice President- Elect for each region (Latin America, North America and Europe), Treasurer and Editor. IPSO's President-Elect position rotates through the three regions and this time the President-Elect will come from Europe. Report from Europe for IPSO Newsletter 2, 2012

After having a longer summer break in most European countries we were back in September into our offices, clinics, seminars and congresses. During the last six months many of us were travelling with books and laptops, digesting new experiences and knowledge. As a result quite a number of ideas came up and here are some 'fruits':

The topic 'Economic Crisis and Psychoanalysis' at the last European IPSO Meeting in Zagreb, was of strong actuality and moved many of us. More or less all

Countries are influenced by the current economic crisis and in Zagreb the participants were very eager to understand more of this situation and its influence on how to work psychoanalytically using the different reflections of colleagues from different countries and regions. Anna Mária can report how this topic was continued at the annual meeting of the Hungarian Psychoanalytic Society in Budapest in a form of a lively discussion group.

As you will see from our report we are still going to have a very busy IPSO year 2013 in Europe. We would be very pleased to welcome many of you at one of these future IPSO events as we think that they provide great opportunities to experience the many different psychoanalytic cultures and languages throughout Europe.

Past Events

5th German Speaking International Psychoanalytic Conference (Deutschsprachige Internationale Psychoanalytische Tagung, DIPsaT), September 27-30, 2012, Berlin, Germany

Although this Conference – taking place every two years in one of the German speaking countries (Austria, Germany or Switzerland) - hasn't got an official IPSO program its structure promotes active participation and involvement of candidates: Lectures and paper presentations by members from one of the five German speaking psychoanalytical societies are usually followed by a comment and discussion of a candidate from a different psychoanalytical society. The overall topic of the Conference was 'The Ability and Capacity of the Language in the Psychoanalytical Process'. Another advantage of the Conference is the possibility to take part and present in supervision groups, which are mixed with analysts and candidates from the five societies. From the candidates' perspective it was very interesting to experience the different cultures in thinking psychoanalytically although every participant was using the same mother tongue German.

Future events

5th IPSO Study Day, February 9-10, 2013, Frankfurt/Main, Germany

Topic: Understanding the Scene - 'Szenisches Verstehen': A Concept of Psychoanalyst and Patient Performing Together

This Study Day will focus on the concept of Szenisches Verstehen' ('Scenic Understanding') from its early developments in Frankfurt to today's interpretation and clinical practice. The concept will be discussed in reference to related theories and also the potential it has for the interpretation of works of art. Three training analysts from Frankfurt – Werner Bohleber, Tomas Plänklers and Rotraut De Clerck – will give lectures and chair clinical workshops. The local organization committee (consisting of Inga Friedrich, Ewa Leban, Sarah Roemisch and Katrin Schwind) is very busy with the organization of the event and looks forward to meeting you in Frankfurt! IPSO Program at the 26th EPF Annual Conference, March 20-24, 2013, Basel, Switzerland

Topic: 'Formlessness: Deformation, Transformation'

As part of the EPF conference, IPSO offers a program providing an important opportunity for the intercultural dialogue between candidates in the pluralistic European psychoanalytical landscape. The IPSO Program will include:

4 IPSO Workshops with the 'Listening to Listening' discussing method (chaired by Haydée Faimberg and Dieter Bürgin), that will be open to candidates and recently graduated members, on **Wednesday March 20, 2013**. There will be two parallel workshops in English and French in the morning (9am-1pm) and in the afternoon (3pm-7pm).

An **opening event** with welcoming words by our hosts and the IPSO Representatives followed by a **plenary session with a paper presentation** and discussion on **Thursday afternoon, March 21, 2013**.

During the EPF Conference we will have **4 supervisions with training analysts** from different countries.

As a traditional part of the IPSO program, there will be an **IPSO After Dinner Party on Friday evening, March 22, 2013** for people to meet, dine, dance, discuss and exchange about psychoanalytical training and practice in the different psychoanalytic traditions and cultures.

22nd IPSO Congress July 30 – August 3, 2013 (in connection with the 48th IPA Congress), Prague, Czech Republic

Topic: 'Facing the Pain: Clinical Experience and the Development of Psychoanalytic Knowledge'

The next IPSO/IPA-Congress will take place in Prague/Czech Republic. With the main topic: 'Facing the Pain: Clinical Experience and the Development of Psychoanalytic Knowledge' this congress will offer a wide range of topics, but mainly aims to explore how analysts and patients face psychic pain in the clinical experience and how these encounters inform the ways we develop psychoanalytic theory and technique. Three major topics will be addressed during the congress: depression, disturbances of affect regulation and disruptions in the process of symbolization.

The IPSO congress program begins on Tuesday 30 July in the morning with a **plenary session and with the IPSO Forum** in the afternoon. The IPSO program will also include **paper presentations, supervisions, Meet-the-Analyst sessions, peer discussion groups, the IPSO Writing Award and the IPSO Business Meeting as well as the IPSO Dinner Party on Friday August 2nd.**

IPSO intends to provide a scientific and social environment where psychoanalytical candidates from all over the world can share their experiences of their training in order to enhance their theoretical and clinical knowledge in an atmosphere of mutual respect. The detailed program is still in preparation and IPSO/IPA Congress registration and accommodation booking opens in January 2013. Topic: 'Time, Temporality and Tempo in Psychoanalysis'

There will be plenty opportunity to present a paper connected to the topic of the meeting, to participate actively in peer supervision and to take part in further IPSO and personal professional developments inspired by such meetings.

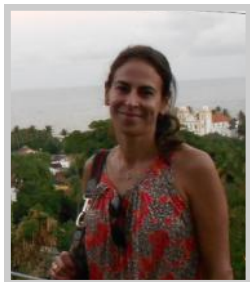
More thoughts on the theme, more details on conditions of presenting papers, or information regarding accommodation, registration fee and travel arrangements will be given later.

Starting with a warm welcome at the airport, Elena Tomasel, President of the Cloister and IPSO Representative of SPPA, opened her home to our L. A. Vice President, Sylvia Pupo and to Thalita Gabino, ABC's Secretary (Brazilian Association of Candidates) who also took part in the Forum. Rita Melo was representing OCAL as Its President. Following the Skype encounters within Latin America held early this year, we are initiating a series of intercontinental activities by videoconference, connecting Latin American candidates-in-training with colleagues in Portugal and Spain.

In the words of Csongor Juhos, Hungarian analyst-in-training in Lisbon (SPP):

"I experienced the virtual meeting on Tuesday with great enthusiasm. The energy generated by the constructive diversity of thoughts and the will (and willingness) to share in a constructive way, is something that should be at the heart of psychoanalysis, however, is rarely found in such pure state".

Thank you all for your participation up to now!

The videoconferences present a limitation as to the number of computers connected, not bearing more than a certain number, depending on the device. We are also learning to improve them.

We are very proud to share with you some of the highlights of the events that we have planned for the next six months leading up to the **22nd IPSO congress from July 30 to August 3, 2013 during the 48th IPA Congress in Prague, Czech Republic.** We have a lot of events and opportunities for knowledge exchange planned for candidates in North America in the next few months! Our goal for the region, that includes the U.S., Canada, Korea, Japan and China continues to be raising awareness about the important psychoanalytic work that happens in our region.

Toronto, Canada: Master Class with Dr. Werner Bohleber, Sunday December 9th 2012

In conjunction with the Toronto Institute of Psychoanalysis (TIP), Dr. Werner Bohleber (Training and Supervising Analyst at the German Psychoanalytical Association, Frankfurt Psychoanalytic Institute) kindly agreed to conduct a **master class** for Canadian candidates at the Toronto Institute of Psychoanalysis. This event took place on **Sunday December 9, 2012** right after the Canadian Psychoanalytic Society and the Canadian Journal of Psychoanalysis Conference: **Trauma, Drives and Reality – A new integration of the mind and therapy.** Where Dr's Bohleber, Joseph Fernando (Training and Supervising Analyst, Toronto Psychoanalysis Society & Institute, whose recent book, *The Processes of Defense*, won the 2010 Gradiva prize for a book on psychoanalytic theory), and Brian Robertson (Training and Supervising Analyst at the Canadian Institute of Psychoanalysis Quebec English branch) will discuss the exciting new perspective proposed in Dr. Fernando's book. The conference highlighted the thoughts and reactions of international and Canadian analysts in the discussion of Dr. Fernando's view of the mind as dealing with internal (drives and emotions) and external (reality) stimulation in different ways, using new concepts for different defenses.

Annual National Meeting of APsaA, New York City, January 13-18, 2013

The annual National Meeting of the American Psychoanalytic Association (APsaA) will convene in New York City on January 13, 2013. As it does each year in conjunction with the APsaA conference, the IPSO Executive Committee will conduct its regular annual meeting. Also, during the week, IPSO will lead Discussion Group 21. Perspectives in Psychoanalysis. The case presentation is entitled, "Maria: Notes on Separation and Intrusion Anxiety." The session will be chaired by Deisy Cristina Boscán, Ph.D. (San Diego, CA), the IPSO Vice President for North America. The presenter will be Graciela Hoyos, M.A. (Cali, Colombia) and the discussants will include Holger Himmighoffen, M.D. (Zurich, Switzerland) the IPSO Vice President for Europe,

Michael Garfinkle, Ph.D. (New York, NY) and Aura Lorenzo, Ph.D. (Mexico City, Mexico), our Vice President-Elect for Latin America. This discussion group will provide a forum for presentation and discussion of clinical cases and theoretical ideas from around the world. After attending this session, participants should be able to describe the different clinical and theoretical perspectives discussed, compare and contrast some of the various psychoanalytic cultures from around the world, and identify new ideas to be utilized in their own clinical practices. IPSO members who plan on attending the APsaA meeting should make a special effort to participate in Discussion Group 21.

SAVE THE DATE: Clinical Working Parties, New York U.S.A., March 2nd and 3rd 2013

On March 2nd and 3rd, 2013 the Clinical Working Party on the "Specificity of Psychoanalytic Treatment Today" will be happening in NYC organized in collaboration with IPSO to make these working parties available for candidates. We hope to have a many spots available for candidates as possible. These working parties will happen at the New York Psychoanalytic Society and Institute. The Working Party on the Specificity of Psychoanalytic Treatment Today is a research method based on an analogical relation between the analytic sessions and their narration.

The Working Party has found that owing to the associative thinking of analysts working together, the clinical research group functions as a magnifying echo of the transference-countertransference relation between patient and analyst. The working party on the Specificity of Psychoanalytic Treatment Today would like to pilot candidate-only groups. This is being done in Latin America and this working party is very interested in trying this kind of group in North America. The organizers of this working party want to have the first candidate-only group in NYC in March 2013 at the Working Party Congress. We are excited about the utility of the methodology for honing psychoanalytic listening skills.

We would like to thank Drs. Bill Glover, Ronnie Shaw and Margaret Ann FitzPatrick-Hanly for their support in providing spaces for candidates in these amazing learning opportunities. Please stay tuned for more details about these exciting opportunities.

IPSO North American Conference, San Diego, March 8-9, 2013

On March 8-9, 2013, IPSO will host its third North American conference entitled, "Journeys in Psychoanalysis: The Clinical Experience on Three Continents." The meeting will be co-hosted by the San Diego Psychoanalytic Society and Institute (SDPSI),

University of California, San Diego (UCSD) and the International Psychoanalytic Association (IPA) and will be held at UCSD's School of Medicine. We have been fortunate in securing the participation as key speakers Professor Peter Fonagy from England, Dr. Virginia Ungar from Argentina, and Dr. Daniel Jacobs from United States, who will discuss four presentations by IPSO candidates from around North America. The conference moderator will be Alan Sugarman, Ph.D., and the session chairs will be Lee S. Jaffe, Ph.D. & Nadine A. Levinson, D.D.S., all SDPSI leaders. The IPSO candidate presenters will be Carlos Almeida, M.D (New York), Cuneyt Iscan, M.D., (Boston); Holly Johnston, Ph.D., (Chicago) and Barbara Mosbacher, Ph.D (Houston). The conference chair and organizer is Deisy Cristina Boscán, Ph.D., IPSO Vice-President, North America.



The conference will endeavor to provide a dimensional view of how psychoanalysis is practiced around the world, noting distinctions among clinical approaches and thinking in North America, South America and Europe. The conference committee believes that all candidates and practicing psychoanalysts, as well as others interested in the field, will find this unique geographic approach to considering the presented cases to be a valuable addition to both their understanding and practice of psychoanalysis and their appreciation of the history of psychoanalysis from the time that Freud began his ground breaking work in Vienna more than a century ago to the present time.

The conference is the first to be held on the west coast and, while attendance of participants from around North America is encouraged, it will afford the opportunity for the first time for candidates and practitioners from the west coast and in nearby states to participate in a conference of this kind in their geographic area. Based on early registrations, those interested in attending the conference should register as soon as possible, as it appears at the time of the publication of this Newsletter that the conference will reach the maximum of registrants well in advance of the conference. During the past ten years much has been said about the crisis going on in psychoanalysis. IPA's Presidents, Regional Presidents, as well as Institute's Director all over the world have wondered about its causes and the possible consequences of this crisis to our profession.

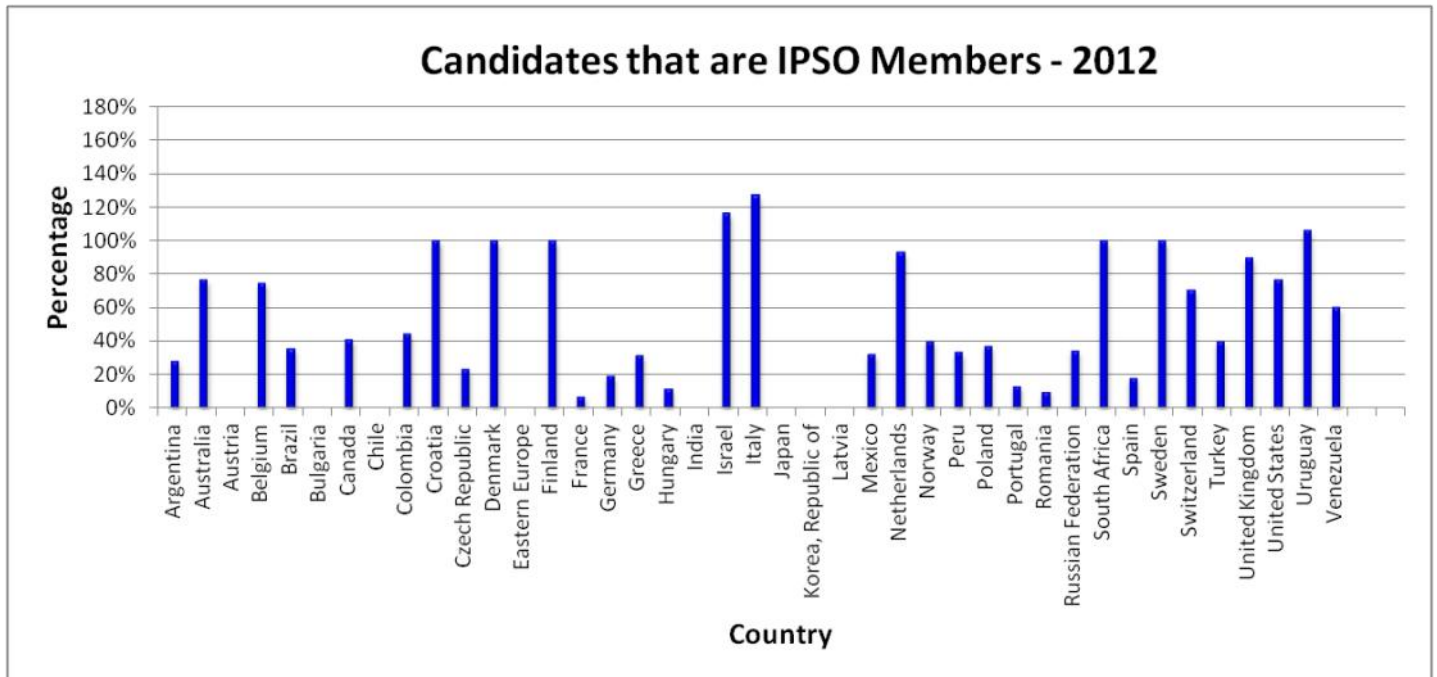
We at IPSO have our own relevant information about this matter, and in fact, IPA's authorities are very interested in getting to know our opinion and receive our feedback.

According to our own history, IPSO was born forty years ago, during an international crisis, and thanks to the initiative of a group of candidates. This is the way the story is being told in our own [webpage](#):

"The International Psychoanalytical Studies Organization (IPSO) was established in 1971. In the late sixties, echoing the worldwide dissatisfaction of a younger generation with authority, a group of candidates planned a demonstration during the 1969 Congress of the International Psychoanalytical Association in Rome. The threat of such a confrontation mobilized the training analysts attending the Congress to consider the possibility of candidate representation, but at a later date. The candidates did not actually stage a demonstration yet held their own meetings at the same time as the IPA, near the official site of the IPA meeting. This group of candidates discussed issues related to training, the lack of candidate representation on committees, and the overall limited inclusion within their communities".

I understand nearly 300 candidates, mainly from Europe and North America, attended that first meeting.

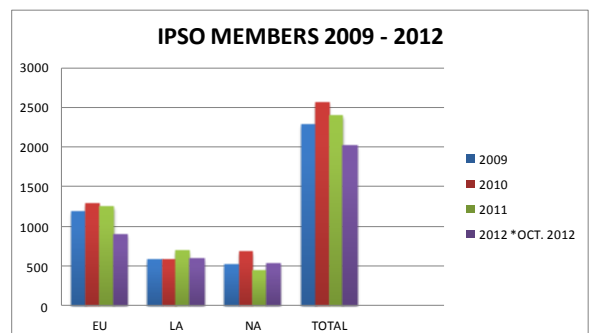
Today IPSO, is a solid and strong organization, with 2,024 members from all over the world. The following chart presents the percentage of IPA's candidates, from each country, that are IPSO members:



When analyzing the amount of members we have had since 2009 (year when I became Treasurer), we can observe the following:

So, should we consider we are being hit by the crisis?

We believe the figures are not yet conclusive since the numbers from this year only go to October. Nonetheless, when IPSO's Executive Committee gathered in New York early this year to plan for the year's upcoming events, we were aware of the circumstances the world was facing. We decided to think ahead and making use of the definition of crisis attributed by some to the Chinese language, considering the whole situation as an opportunity rather than a risk. Under the leadership of our President, and with the support of the whole Executive Committee, two important economic decisions were made:

1. To triple the Awards to be given during the Prague Congress, and to increase the amount of money to be awarded to each one of the winners.
2. To promote and execute a raffle among IPSO members of each of the three regions; the prize is a free registration fee to the IPA- IPSO Congress in Prague.

The first one of these raffles has already taken place in Latin America. It was conducted during FEPAL-OCAL's Congress held in Sao Paulo, Brazil, and the winner was REJANE GANZAROLLI from Sao Paulo's Institute.

The Vice Presidents for Europe and North America shall be announcing soon when and where the raffles corresponding to their regions will be held.

It is also very important to announce to all of you that the IPA/ IPSO Relations Committee, one of the IPA's Committees, has been studying the situation of candidates all around the world. Soon we expect to present some proposals based on our work.

One major result already obtained, was the work developed during this year with the members of IPA's Candidates Loans Panel. We were able to bring support to candidates during the application process, as well as to listen to questions and worries that were presented to the Panel members. We look forward to continuing our work together. We invite all candidates to ask questions and to share your doubts and experiences related to IPA's Candidates Loans. This information would be very useful to us.

Timothy Wilken, considers that the Greek definition of the word crisis is somewhat different and yet the same as the Chinese definition. From his point of view the Greeks define crisis to mean a decision, a choice, the turning point for good or bad.

For IPSO this has been a year of decision-making and implementing changes. While we believe these changes will benefit our members, we are pleased to say that they also support the original proposals formulated by our founders.

Following Wilken's thoughts, we can say that all of these changes represent life, and I dare to add, also progress.

Dear Colleagues,

Another year is coming to an end. You will have noticed by reading the reports of my colleagues that this second half of the year has been busy for IPSO in our attempt to promote an attitude of sharing, respect and openness between colleagues from similar or different psychoanalytic traditions and within the regions and between regions.

In addition to reporting what we have done this semester, much of our attention is focused already on planning our next IPSO Congress in Prague 2013. We encourage you to attend the Congress, a conference created by analysts in training, for analysts in training.

Many activities that traditionally are part of the program will be again present in 2013, however, we are finalizing details to add new ones that we consider will be of interest to you and which will be advertise later.

In my role as Editor, I take this opportunity to address and inform you that in recent months, thanks to the extension of the deadline for submission of proposals made until November 1, 2012, there was an enthusiastic response from our colleagues who submitted to participate in the IPSO Congress in Prague 2013. Candidates from all regions of the IPA have sent their interesting papers that will contribute enormously to the creation of a great congress.

Now, I would like to explain briefly the process by which we select the proposals for Congress. There is a first phase, the **Admission** phase where we review that the proposal meets all the requirements for its participation, including the authors being current IPSO members and up to date with IPSO and have submitted all the requirements in form and content and attached

the complete work before the closing date. In the second phase, the **Assessment**, we assign randomly every proposal for evaluation by three competent reviewers in the official language (English, Spanish, French or German) of the proposal. Each evaluator receives the proposal without the author's identification data for greater objectivity and score it based on the criteria of originality, relevance and clarity of thought. In the next phase, the **Selection and Notification** the top rated proposals are chosen to be presented at the general congress. Later, during the first quarter of 2013 the colleagues will be informed if their papers were selected or not for presentation. The information about the identity of the evaluators and the contents of the assessments is confidential and will not be released under any circumstances. The IPSO Writing Award follows the same phases of evaluation. This year we will have two awards for each region and presenting in the Congress is one of the benefits of the Award.

About supervisions with recognized training analysts, I want to tell you that we have received many proposals with interesting clinical material. The selection of the proposals will be based on two main criteria: the educational relevance of the proposal and the possibility of finding a suitable supervisor from another region for the particular clinical material. While our intention is to respect the official language of preference of the candidate's submission, we request our colleagues to be available to supervise in English if it is not possible to find a supervisor in that language. Additionally, the advantage of English is that more people may attend and participate in the discussion.

On behalf of the IPSO Publication's Committee and the Executive Committee, I want to thank all participants for their enthusiasm in submitting proposals and explain to you that we have limited space, and many activities planned for this Congress Prague 2013, so that some proposals may not be included in the program at this time. We encourage you to keep writing and participating in future IPSO meetings at regional and international conferences.

Please remember that participating, writing and communicating between colleagues allow us to build the necessary bridges to create our psychoanalytic community and continue its development. Together we can build knowledge and further our

progress as we do experience in the work of the analytic dyad.

Finally, during the Executive Committee meeting in January 2013, we will define with more certainty the activities of the Prague Congress 2013 and will send you as soon as we can the provisional program to encourage you to attend.
